Emergency Care discharge standard

Updates have been made to the standard as part of this maintenance release due to:

- Alignment with the Core Information Standard (CIS).
- Alignment with other completed <u>PRSB standards</u> projects since the previous release.
- Alignment to FHIR standards includes updated value sets for many elements.
- Maintenance issues raised by users and logged since the previous release.
- **Must have's** have been considered and updated.
